Subject: REMINDER: League Filming Policy

League Reps,

REMINDER: The "Scout Filming or Video Recording" of NJSYFL games during the regular season, by coaches or representatives from any program, **of a team that the filming program is about to play, in a regular season game, in a subsequent regular season week**, is not permitted by the NJSYFL. Gathering of "game film" of opponents, prior to playing them in the regular season, gives an unfair advantage to the filming team, because not all programs have the means to gather film equally across the league. This has been an NJSYFL standing policy for a number of years.

Programs/Coaches/Program Representatives/Agents that are determined by the League Executive Board to be gathering film in this manner, for this purpose, will be awarded a forfeit. If multiple infractions are determined from this point forward, The League Executive Board will apply additional corrective measures.

Please notify all coaches in your respective programs about this policy, immediately.

Any film already gathered in this manner, should be surrendered to the League Executive Board at this time.
